On January 27, 2014, Institutional Shareholder Services (ISS) released its Governance QuickScore 2.0 technical document outlining key changes to the governance scoring model for QuickScore 2.0 for 2014. QuickScore 2.0 ratings will be published on February 18, 2014. **Requests for data changes submitted prior to 8 pm EST on February 7th will be considered by ISS and reflected when QuickScore 2.0 is released.** The data verification site will remain open following the release to allow for updates of QuickScore 2.0 throughout the year.
